1. Subject of public procurement: Service (number JN 401-1-40 / 2019)

Description of the subject of public procurement:for awarding public-private partnership contracts without the elements of concessions for carrying out energy service, PPP project for reconstruction, rationalization and maintenance of public lighting, implementation of electricity saving measures on the territory of settlement Vrbas, Municipality of Vrbas

(code and mark from ORN: 71314200 Energy management services, 71314300 Energy efficiency consulting services, 50232100 Street lighting maintenance services and 50232110 Commissioning of public lighting devices)

2. Conditions for participation in the procedure (participation right, evidence of eligibility ...):

All bidders who meet the conditions prescribed by the Article 75 of the Law on Public Procurement ("Official Gazette of the RS" No. 124/2012, 14/2015 and 68/2015) have the right to participate and they are obliged to submit the evidence prescribed by Article 77 of this Law. (the supporting evidence will be specified in the tender documentation).

3. Criteria and elements of the criteria for selecting the best bid:

The criteria for selecting the best offer is the net present value related to the total costs in the contracted period excluding VAT.

4. Inspection and download of tender documentation (conditions, place, time, term, ...):

All interested bidders can inspect and download the tender documentation at the premises of the Vrbas Municipal Administration, 89 Marsala Tita Street Vrbas, office 15/2 (Public Procurement Department), every working day from 9 a.m. to 1 p.m., as well as on the website of the contracting authority www.vrbas.net, the Portal of the Public Procurement Administration, the Official Gazette of the

Republic of Serbia, as well as in the mass media distributed on the whole territory of the Republic of Serbia.

5. Submission of bids (term, place, method, indication...):

Interested Bidders should submit their bid within 52 days from the date of publication of the Call for Tender on the Public Procurement Portal of the Public Procurement Administration on the last day of the contest, i.e. on 9th December 2019 until 10.30 a.m. If the last day for submission of bids is the day that is not working day for the contracting authority, the last day for submission of bids will be the first following working day. The bid must be submitted in the closed envelope on the recipient Vrbas Municipal Administration, 89 Marsala Tita Street Vrbas. The name, telephone number and address of the bidder must be clearly written on the back of the envelope.

Bidders submit their bid personally to the office or by post.

Timely bid is the bid received by the contracting authority within the term for submission of bid.

6. Opening of bids (place, time, presence of interested parties ...):

Bids will be opened publicly at the premises of the Municipal Administration of Vrbas, 89 Marsala Tita Street on the last day 09th December 2019 at 11 a.m. Only authorized representatives of bidders may actively participate in the procedure.

7. Term for the decision on award of contract

The decision on award of contract will be made within 40 days from the date of the opening of tenders.
